The heroic struggle of the Railwaymen has been withdrawn unilaterally by the National Co-ordination Committee for Railwaymen's struggle from 06 hrs of 26.5.74 .

It was expected that the Govt. of India would release all the arrested persons unconditionally and start negotiation on the chart of demands submitted by the NCCRS.

26/6/74 But it is noticed that many persons arrested under MISA, MPC, D.I.R. have not yet been released. The court cases have not yet been withdrawn. On the contrary, persons are being arrested on some flimsy grounds. The unexecuted warrants have not yet been recalled. The Govt. have refused to start negotiation on the chart of demands. Thus the Govt. have gone back from their earlier commitments.

Thousands of Railwaymen have been removed from service most illegally and many Railwaymen have not yet been allowed to resume duty and the notices for vacation of Railway quarters have not yet been withdrawn.

It is expected that the Govt. will understand that by way of punishment and harassment normalcy in the working of Railways cannot be restored, and it can only be restored on the Co-operation of the Railwaymen. But Co-operation of the Railwaymen cannot be expected, most reasonably, by suspending and removing thousands of Railwaymen, keeping them behind the bar for indefinite period and locked them up in court cases, and denying the rightful claims of the Railwaymen.

This meeting of the NCCRS held at Malda Town on 18th June, 1974 in observance of "All India Anti repression Day" demands:-

1. All the arrested persons be released unconditionally
2. All the court cases be withdrawn and unexecuted warrants recalled.
3. All the Railwaymen kept under suspension or terminated from service be re-instated in the service.
4. The negotiation on the charter of demands submitted by the NCCRS be started immediately.

This meeting express its gratitude to all the workers, peasant, youths, student, ladies and gentlemen of the locality for their Co-operation and assistance during the struggle and also during post struggle period. This meeting calls upon the Railwaymen to maintain unity and solidarity to get the victimisation vacated and to achieve the demands.
