- SHRI PRANAB MUKHERJEE: Somebody from the Treasury bench should have taken it up. If they don't take it up, how could it be there? Madam, they are functioning in a very strange way.
- SHRI SATISH AGARWAL: What is the Parliamentary Affairs Minister doing there? It is a serious matter. That is why I objected to it. What will happen to it? We cannot join in that Committee. Our House will not join in that Committee. We cannot hold election, because the Resolution is not moved by anybody.

- SHRI SATISH AGARWAL: The Minister must be hauled up. This House cannot be treated like this. We have been treated very shabily that way.

# MOTION FOR ELECTION TO THE JOINT COMMETTEE

#### ON OFFICES OF PROFIT

THE MINISTER OF STATE (INDEPENDENT CHARGE) OF THE DEPARTMENTS
OF LAW AND JUSTICE (SHRI RAMAKANT D. KHALAP): Madam Deputy

Chairman, I move the following Motion:-

"That this House concurs in the recommendation of the Lok Sabha that a Joint Committee of the Houses to be called the Joint Committee on Offices of Profit be constituted for the purposes set out in the motion adopted by the Lok Sabha at its sitting held on the 12th July, 1996, and resolves that this House do join in the said Joint Committee and proceed to elect, in accordance with the system of proportional representation by means of the single transferable vote, five Members from among the Members of the House to serve on the said Joint Committee."
